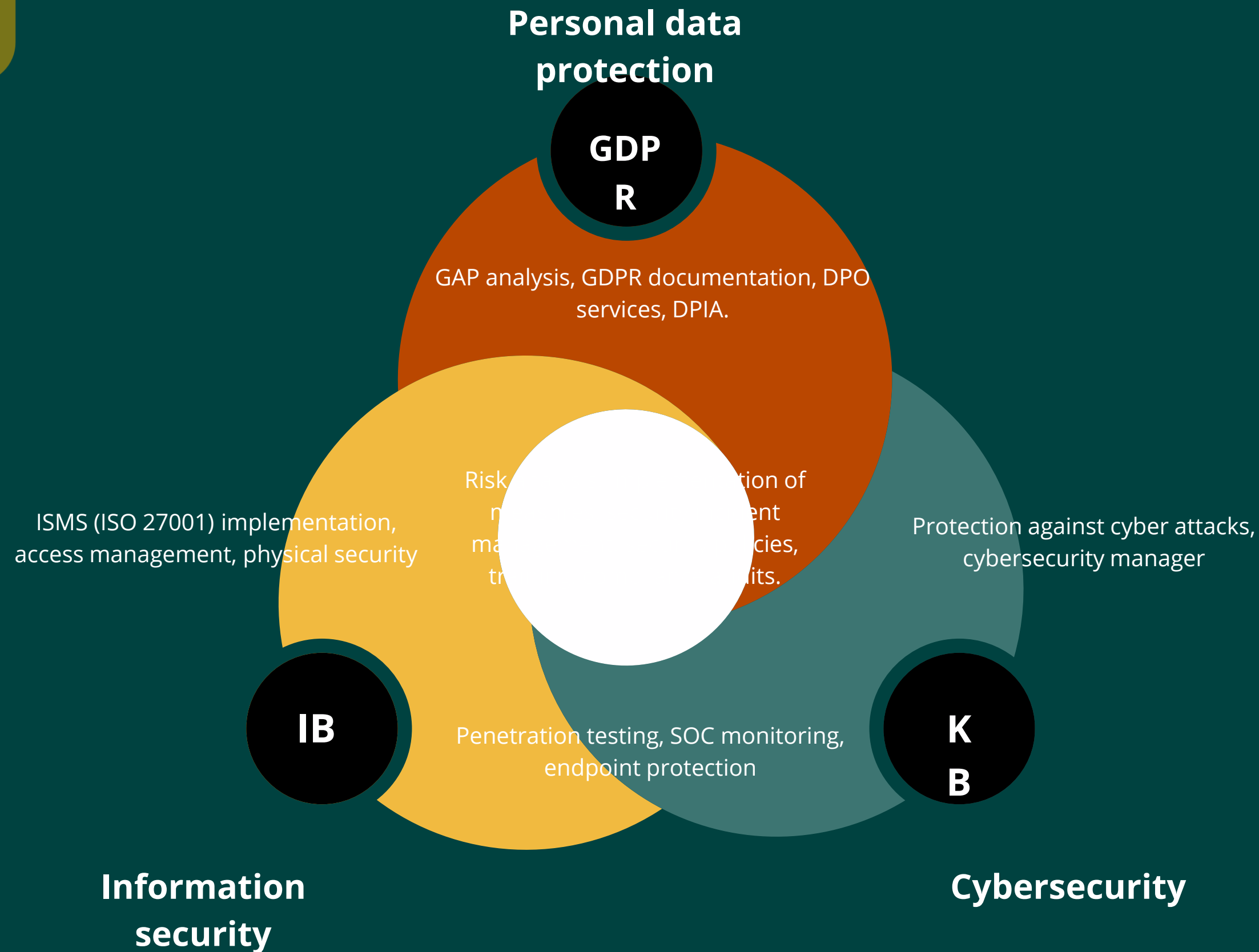

- **Firewall and endpoint protection** – Securing workstations, servers and the corporate network from unauthorized access.

Without information security, the GDPR would not be able to be implemented effectively, because this is where technical and organizational measures for the protection of personal data are set.
